U.S. government health officials are investigating a possible connection to recent illnesses and romaine lettuce. No recall is currently in place.

We take all food safety concerns seriously and want to offer alternatives if you choose to discontinue serving romaine. We have attached our current packs of whole and processed romaine with suggested alternatives. Please contact your account representative with any additional product related questions.

Overview (what we currently know) as Jan 5, 2018 at 9am:

 - To date no definitive source of the outbreak has been confirmed and no other health agency has issued an advisory, statement or recall of any leafy greens product.
- As of today, the Canadian Public Health Authority website has not yet been updated.
- United Fresh is actively working on and monitoring the issue on behalf of the industry.

We will continue to monitor this situation and update with any additional details as they become available.

We have monitored the current outbreak of E.coli in Eastern Canada linked to romaine lettuce since it was first reported in December. We are aware that there are potentially related illnesses in the United States.

What we currently know as Jan 4, 2018 at 9am:

- To the best of our knowledge, Church Brothers/True Leaf Farms product is not involved and we have not been contacted by any federal, state or local government agency regarding this or any other outbreak.
- Only limited details have been made available to the public. The summary was shared by the California Leafy Greens Marketing Agreement on of December 21: <u>http://www.lgma.ca.gov/2017/12/monitoring-canadas-ecoli-outbreak/</u>
 - To date no definitive source of the outbreak has been confirmed and no other health agency has issued an advisory, statement or recall of any leafy greens product.
- As of today, the Canadian Public Health Authority website has not been updated yet. We will continue to monitor and let you know if there are any changes.
- United Fresh is actively working on and monitoring the issue on behalf of the industry.

What we have done to date:

- Our first statement acknowledging our awareness of this issue was drafted on Friday, December 21.
- We have continued to stay in touch with our industry trade leadership to make sure that we are up-to-date on all latest details.
- We have checked our recent farming and harvesting food safety data to assure there are no additional provisions that are warranted to assure the safety of our consumers.
- As of Jan 4, 2018 9am: There are no new official updates. When more official updates are released, we will keep you informed.
